## OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON JANUARY 24, 2023

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 24<sup>th</sup> day of January 2023, at 9:33 a.m., at the Canosia Towns Hall, Duluth, Minnesota, with the following members present: Commissioners Annie Harala, Ashley Grimm, Paul McDonald, Keith Musolf, Keith Nelson, Mike Jugovich and Chair Patrick Boyle - 7. Absent: None - 0.

Chair Boyle asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance.

Commissioner Musolf introduced Canosia Township Supervisors Kevin Comnick and Jeff Erickson. Supervisor Comnick commented that the last County Board meeting held in Canosia was in 2013 and the Board is meeting in the original town hall that was built in 1888. Supervisor Comnick said that St. Germain's Glass Company recently opened a new manufacturing facility and The Tongue and Groove Store just finished their expansion. In addition, the Pike Lake Golf and Beach Club just completed construction of their event center and golf simulator and will be starting construction of 74 townhomes around Pike Lake.

Chair Boyle opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Melissa Bell, of Duluth, commented regarding the Conditional Use Permit (CUP) issued to 6464 Fredenberg Lake Road. Ms. Bell provided the Board a handout and commented that there is not a 60-day time limit to have the permit voided and the case was not heard in court because the judge dismissed the case. Ms. Bell said the CUP should be voided due to multiple issues including: the septic tank not being in compliance when the permit was granted, LTI Holdings were not the owners of the property when the permit was issued, the sketch site map omitted a residence, and the applicant owns another gravel pit with severe reclamation issues. Clayton Cich, of Fredenberg Township, commented that the county is violating civil rights by treating certain people under the same laws differently. Mr. Cich commented they have experienced difficulties when dealing with the county and that a complaint has been filed with the new County Sheriff. Mr. Cich said they may have to look to a federal magistrate to give the county some help from the outside. Bruce Anderson, of Duluth, commented that he does not think county operations are running smoothly on this issue and citizen concerns are not being met. Mr. Anderson said that County Commissioners are responsible for ensuring that citizen concerns are met. Leeana Process, of Duluth, said the gravel pit will have a significant impact on her life due to noise pollution, dust and high traffic. Ms. Process commented that many people cannot come forward due to scheduling or because they are broken hearted. Oly Olson, of Duluth, said they are trying to protect their way of life in their neighborhood. Mr. Olson said the name for the civil rights violation by the county is "disparaging treatment"; townships and neighborhoods are being treated differently and it needs to stop because it is illegal. Kevin Comnick, Chair of the Canosia Township Board, commented that he has worked with the County Board over the past seventeen years and they have always been easy to work with. The working relationship between the township and county is strong.

At 9:59 a.m., a public hearing was conducted, pursuant to Resolution No. 22-666, adopted December 13, 2022, to consider the amendment of the 2023 Fee Schedule for The Depot Theatre rental fees, merchandise, and property management services at the St. Louis County Heritage and Arts Center (The Depot). Brian Fritsinger, St. Louis County Deputy Administrator, gave the Board

an overview of proposed fees. Deputy Administrator Fritsinger commented that County Administration is requesting that three (3) additional fees (Brian Fritsinger handout) relating to the rental of the Theatre be included in the fee schedule. Commissioner Nelson commented that he did not believe that the merchandise fees belonged on the fee schedule because suppliers could change pricing. Chair Boyle asked St. Louis Assistant County Attorney Chris Pinkert if there was any legal requirement for the inclusion of merchandise fees in the fee schedule. Assistant County Attorney Pinkert commented that he was not aware of any requirement for the inclusion of merchandise fees on the fee schedule. Chair Boyle asked if there were any other governmental entities, supporters, or opponents who wished to speak regarding the proposed action; no one requested the opportunity to speak. Chair Boyle asked if there were any other comments from the public. Clayton Cich, of Fredenberg, commented that he was in the concession business for 12 years and recommended that the county use an outside vendor or the existing on-site vendor. At 10:09 a.m., Commissioner Nelson, supported by Commissioner Grimm, moved to close the public hearing. The motion passed; seven yeas, zero nays.

Commissioner Nelson, supported by Commissioner Harala, moved that the St. Louis County Board of Commissioners amends the 2023 Fee Schedule for fees associated with the St. Louis County Heritage and Arts Center with the addition of three (3) Theatre rentals fees (Brian Fritsinger handout) and striking merchandising fees for t-shirts, ceramic mugs, travel mugs, totes, and stickers. The motion passed; seven yeas, zero nays. Resolution No. 96.

Commissioner McDonald, supported by Commissioner Harala, moved to approve the consent agenda. The motion passed; seven yeas, zero nays.

WHEREAS, Public Works found it necessary to expand brine storage capacity and blending capabilities at the Ely campus; and

WHEREAS, The existing Construction Manager at Risk (CMAR) contract with McGough Construction Incorporated of Duluth, MN, includes the construction of brine buildings at the Culver, Kugler and Whiteface campuses; and

WHEREAS, The proposed Ely brine build is a duplicate of the previously designed brine buildings in Culver, Kugler and Whiteface; and

WHEREAS, The engineering was already completed and replicating the building in Ely was pragmatic; and

WHEREAS, McGough is able expand the materials order and provide the additional labor necessary; and

WHEREAS, An amendment to the existing CMAR contract with McGough for the proposed Ely brine building is advantageous for timing, scope of work, contract administration and cost effectiveness; and

WHEREAS, The building permits, negotiated fee for overhead and profit, project contingency, bond and insurance costs shall not exceed \$23,610,123.68.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes an amendment to the professional services contract with McGough Construction of Duluth, MN, and approves any amendments authorized by the County Attorney, for the CMAR services, with a guaranteed maximum price (GMP) for the Public Works County Wide Improvements construction project in an amount not to exceed \$23,610,123.68 payable from Fund 450, Agencies 450002 (Culver), 450003 (Kugler) and 450004 (Whiteface), Object 660266 with costs split between these three agencies.

RESOLVED FURTHER, That the additional cost of \$180,000 to construct a brine building in Ely shall be payable from Fund 405, Agency 405182, Object 660266 and shall not utilize bond funds.

WHEREAS, On March 11, 2021, the President of the United States signed into law the \$1.9 Trillion American Rescue Plan Act (ARPA) to provide continued relief from the impact of COVID-19 pandemic; and

WHEREAS, Approximately \$350 billion of the ARPA funding was allotted to assist state, local tribal, and territory governments in responding to the COVID-19 pandemic; and

WHEREAS, Funds received are required to be used in accordance with the Coronavirus Local Fiscal Recovery Fund (CLFRF) requirements as provided within the guidance issued by the United States Treasury:

- > To respond to the public health emergency
- > Top address its negative economic impacts
- > To serve the hardest hit
- > To make necessary investments in water, sewer, or broadband infrastructure; and

WHEREAS, St. Louis County has been awarded \$54,536,596 in ARPA funds to be used in accordance with the above requirements; and

WHEREAS, The Duluth Housing & Redevelopment Authority (HRA) has been actively working to develop the Skyridge Flats senior project as the fifth phase of the HOPE VI plan being developed on the Harbor Highlands site in Duluth; and

WHEREAS, The COVID-19 pandemic and its lingering effects has put additional stresses on a variety of housing units including those units dedicated for seniors; and

WHEREAS, The HRA has submitted documentation seeking funding assistance from the County's ARPA funds to develop a 70-unit senior housing project; and

WHEREAS, The HRA has further submitted documentation seeking funding assistance from the City of Duluth for a similar level of funding to support this project.

THEREFORE, BE IT RESOLVED, That after the review of the Project Eligibility form, application and other submitted materials, the Skyridge Flats senior housing project proposed by the Duluth HRA is eligible under US Treasury Final Rule guidance.

RESOLVED FURTHER, That the St. Louis County Board approves the use of \$150,000 of American Rescue Act Plan funding to the Duluth HRA for the construction of 70-units of low-income senior housing units.

RESOLVED FURTHER, That all construction and renovations shall be in compliance with local zoning regulations and state building code.

RESOLVED FURTHER, That the Duluth HRA shall comply and submit all necessary information, documentation and reporting materials required by the County, State or US Treasury to ensure that the project meets any and all conditions as required under the American Rescue Plan Act or the County.

RESOLVED FURTHER, That the above project be payable from Fund 239, American Rescue Plan Act.

experiencing longer meetings that require a vast amount of preparation; and

WHEREAS, The requested increase to the per diem rate is \$150 for each meeting attended. THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes an increase to the per diem rate for the Planning Commission and Board of Adjustment members from \$100 to \$150 for each meeting attended and reimbursement for round-trip mileage at the applicable rate authorized by the County Board.

WHEREAS, State Law requires all public jurisdictions to eliminate any gender-based wage inequities in compensation; and

WHEREAS, By continuing to review its pay equity, the County remains in compliance; and WHEREAS, The 1984 Local Government Pay Equity Act mandated that each political subdivision establish a job evaluation system in order to determine the comparable work value of each job classification in its employment, and to establish and maintain equitable compensation relationships between female-dominated and male-dominated job classes; and

WHEREAS, According to the current report, St. Louis County continues to maintain compliance with the Pay Equity Act.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board approves the 2023 St. Louis County Pay Equity Implementation Report and authorizes the Board Chair to sign the report to be submitted to the State of Minnesota by the January 31, 2023 deadline.

WHEREAS, Enbridge used Lidar imagery along with tree counters to get accurate tree number estimations before clearing and added 30% to account for potential mortality of the future planted seedlings; and

WHEREAS, Enbridge is estimating 13,446 trees were cut in workspaces located on state tax-forfeited and county-owned fee lands for a total compensation of \$107,567.20.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board authorizes the Land Commissioner to accept \$107,567.20 from Enbridge Energy, Limited Partnership as part of the Treefor-Tree Replacement Program to be used to purchase tree seedlings for future planting at locations determined by the County.

RESOLVED FURTHER, That the funds will be deposited into Fund 290 and administered according to the requirements of the program.

WHEREAS, The Land and Minerals Department recommends that this parcel be reclassified as non-conservation after considering many factors including the present use of adjacent land, the accessibility of lands to established roads, schools, utilities and other public services, and its peculiar suitability or desirability for particular uses; and

WHEREAS, This parcel of land is located inside the boundaries of a municipality or town, and Minn. Stat. § 282.01 provides that classification or reclassification and sale of lands situated within a municipality or town must be approved by the governing body of the municipality or town; and

WHEREAS, The reclassification and sale of this parcel will be deemed approved if the county board does not receive notice of the municipality's or town's disapproval of the

reclassification and sale of the parcel within 60 days of the date on which this resolution is delivered to the clerk of the municipality or town in which the parcel is located; and

WHEREAS, This parcel of land has not been withdrawn from sale pursuant to Minn. Stat. §§ 85.012, 92.461, 282.01, subd. 8, and 282.018, and other statutes that require the withholding of state tax-forfeited lands from sale.

THEREFORE, BE IT RESOLVED, That the St. Louis County Board approves the (a) reclassification to non-conservation and (b) sale of state tax-forfeited land, as described, to Thomas M. Conaway for the price of \$15,900 plus the following fees: survey cost of \$3,529, 3% assurance fee of \$477, deed fee of \$25, deed tax of \$52.47, and a recording fee of \$46, for a total of \$20,029.47 to be deposited into Fund 240 (Tax-Forfeited Land Fund).

RESOLVED FURTHER, That the request for approval of the reclassification shall be transmitted by the St. Louis County Land and Minerals Department to the clerk of the municipality or town in which the parcel is located.

RESOLVED FURTHER, That the reclassification of this parcel will be deemed approved if the county board does not receive notice of the municipality's or town's disapproval of the reclassification of any parcel within 60 days of the date on which this resolution is delivered to the clerk of the municipality or town.
