OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON JUNE 6, 2023

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 6th day of June 2023, at 9:32 a.m., at the St. Louis County Courthouse, Duluth, Minnesota, with the following members present: Commissioners Annie Harala, Ashley Grimm, Paul McDonald, Keith Musolf, Keith Nelson, Mike Jugovich and Chair Patrick Boyle - 7. Absent: None - 0.

Chair Boyle asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance.

Chair Boyle opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Melissa Bell, of Duluth, said that the Conditional Use Permit (CUP) issued to 6464 Fredenberg Lake Road was issued in error and the CUP should be null and void. Ms. Bell commented that information was hidden from the Planning Commission. In addition, Ms. Bell said that Commissioner Nelson refuses to tell her who requested that he read a letter during the May 2, 2023, Board meeting. Clayton Cich, of Fredenberg Township, commented on the need for the McKeever gravel pit to be inspected and discussed issues with a snowmobile club trail that goes though the pit.

Commissioner Musolf, supported by Commissioner McDonald, moved to approve the consent agenda. Item #6, Appointment of the 2023 Special Board of Appeal and Equalization, was removed from the consent agenda for separate consideration. The motion passed; seven yeas, zero nays.

Commissioner Nelson, supported by Commissioner Harala, moved that the St. Louis County Board appoints the following individuals to serve as the Special Board of Appeal and Equalization for Assessment Year 2023: District 1 - John Vigen, Duluth; District 2 - Nathanael DeLoach, Duluth; District 3 - Sherri Puckett, Duluth; District 4 - Leonard Cersine, Ely; District 5 - Tim Peterson, Hermantown; District 6 - Dawn Cole, Town of Fayal; District 7 - Frank Bigelow, Hibbing; and further, that the Special Board of Appeal and Equalization is: delegated all powers and duties of the County Board of Appeal and Equalization; to report the results of their deliberations back to the St. Louis County Board in the form of minutes kept by the Clerk of the County Board; directed to hold at least one meeting day in Duluth, and one day in Virginia, Minnesota; to be compensated at the rate of \$300 per meeting day, payable from Assessor's Department Fund 100, Agency 118001, Object #635300 - Non-employee fees and be reimbursed for mileage and expenses at the current CONUS rate from Assessor's Department Object #635500 - Non-employee travel; and directed to convene at 10:00 a.m., June 19, 2023, in Duluth, MN. Chair Boyle, supported by Commissioner Harala, moved to amend the motion to change the convene date from 10:00 a.m., June 19, 2023, in Duluth, MN, to 10:00 a.m., June 21, 2023, in Virginia, MN. Chair Boyle noted the change was necessary in observance of the Juneteenth holiday. The amendment passed; seven yeas, zero nays. The motion as amended passed; seven yeas, zero nays. Resolution No. 23-302.

Commissioner Harala, supported by Commissioner Grimm, moved that the St. Louis County Board approves the write-off of five accounts totaling \$126,423.44 in which the collection of required claims have been unsuccessful. County Administrator Kevin Gray commented that the names associated with the write-off amounts are not included in this document because the data is non-public information as outlined in MN Statute § 13.46. Commissioner Nelson commented that he was
