The Board of County Commissioners of the County of St. Louis, Minnesota, met this 4th day of April 2023, at 9:31 a.m., at the St. Louis County Courthouse, Duluth, Minnesota, with the following members present: Commissioners Annie Harala, Ashley Grimm, Paul McDonald, Keith Musolf, Keith Nelson, Mike Jugovich and Chair Patrick Boyle - 7. Absent: None - 0.

Chair Boyle asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance.

The St. Louis County Board proclaimed the week of April 2-8, 2023, as Public Health Week in St. Louis County, in appreciation of the work of staff and community partners and in recognition of the vital role of public health in the work ahead. Commissioner McDonald read the proclamation. St. Louis County Public Health and Human Services Director Linnea Mirsch commented that partnership is the fabric of public health, and it is fitting that we honor our staff and partners this week. The Board recognized the following organizations and individuals with Public Health Partnership awards: Duluth City Councilor Terese Tomanek, Rural Aids Action Network (RAAN), First Ladies of the Hillside, and the Ely Community Health Center.

A point of personal privilege was taken at 9:49 a.m. At 9:53 a.m., the Board reconvened with all members present.

Commissioner Grimm temporarily stepped out of the meeting from 9:54 a.m. to 9:59 a.m.

Chair Boyle opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Melissa Bell, of Duluth, provided the board with a handout and said the McKeever gravel pit has unresolved reclamation issues and questioned how the reclamation can take place after looking at photos and doing the math. Ms. Bell requested that a third party conduct an inspection of the gravel pit. said that there has been unequal treatment of gravel pits and per county ordinance; the Conditional Use Permit (CUP) issued to 6464 Fredenberg Lake Road should be revoked. Bonnie Anderson, of Duluth, reviewed a list of questions to Commissioners regarding the issuance of the Conditional Use Permit (CUP) to 6464 Fredenberg Lake Road. Clayton Cich, of Fredenberg Township, said the township has been asking for gravel inspections since June of 2022 and only two gravel pits have been inspected. Mr. Cich commented that one gravel pit operator is completely out of control. Ann Cich, of Fredenberg Township said elections are held to vote for people who protect you and your quality of life and asked the Board to consider how they are affecting the quality of life in Fredenberg. Bruce Anderson, of Duluth, referred to section 6.22 of St. Louis County Ordinance 62 and said that one line alone should be enough to rescind the CUP issued to 6464 Fredenberg Lake Road. Janet Olson, of Duluth, said the county is not considering the love, time, and passion of Fredenberg Township residents and the Board is not considering the impacts that the 6464 Fredenberg Lake Road CUP is having on the community.

Commissioner Jugovich, supported by Commissioner Harala, moved to approve the consent agenda. The motion passed; seven yeas, zero nays.

WHEREAS, By accepting the anticipated funds now, the County and Bois Forte can keep ahead of timelines and be able to complete all needed transfer documents to allow Bois Forte to become the applicant.

years, to be accounted for in Fund 100, Agency 132999 Grant 13215, Year 2022.
