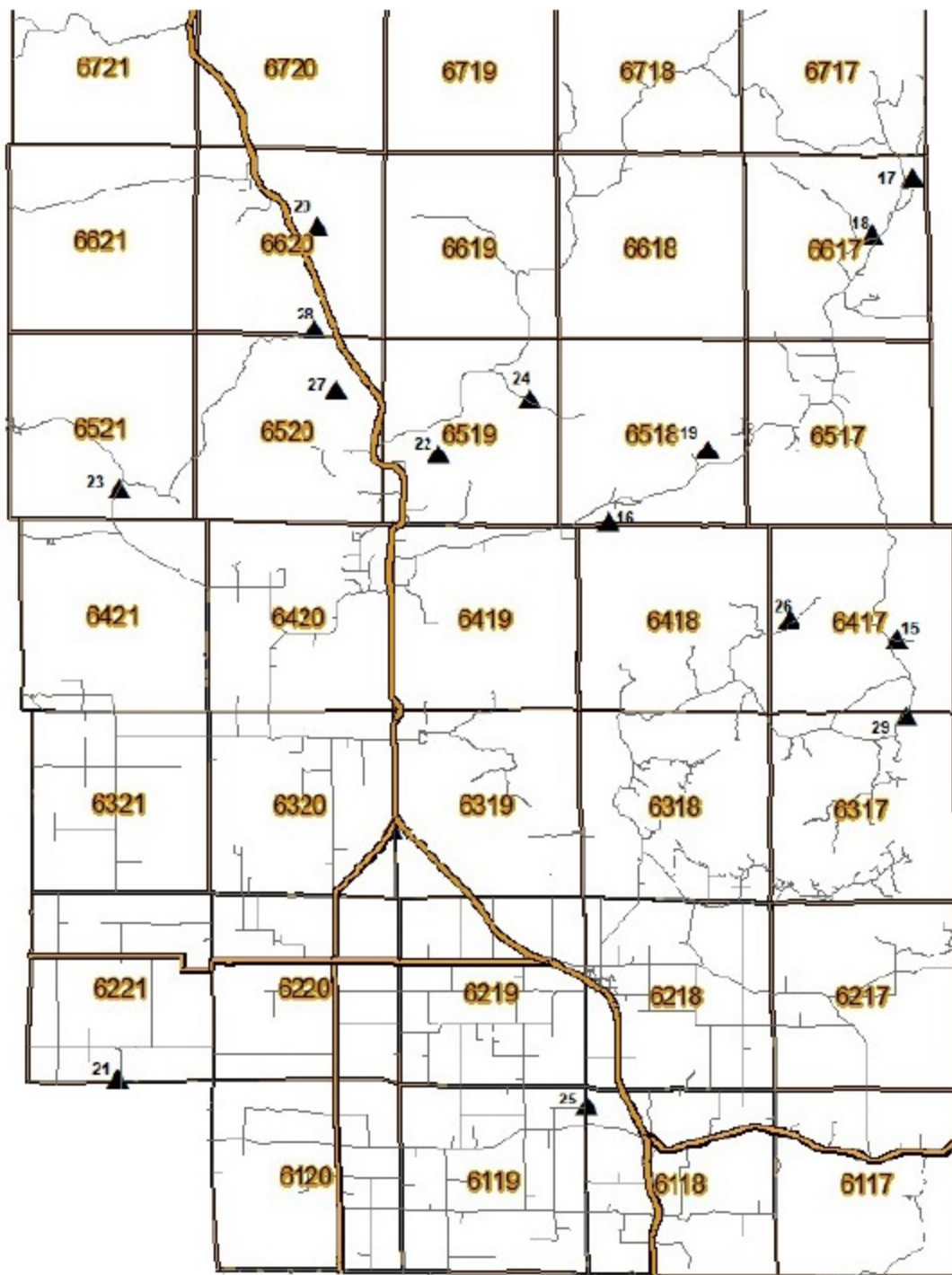

15. Ahlgren	NE-SW 23-64-17	\$2.50	N	4	N	Mix of sand, gravel, and cobbles
16. Counihan	SW-SE 32-65-18	\$2.50	N	4	Y	Access through private property. Remaining material quality/quantity unknown.
17. Crane Lake	NW-SE 1-66-17	\$2.50	Y	4	Y	Multipurpose pit with variable, mixed materials. South bank closed, ledge on East bank. Shared access with canister site and communication tower, multiple locks.
18. Dry Pine – Goldmine Road	NW-SW 14-66-17	\$2.50	N	4	N	Sandy, some gravel and cobbles. Opened by PW for winter sand, but not used recently. Observe USFS property line on East side and private 2.5 acres in Northeast corner.
19. Jack Pine Ridge	NE-SE 23-65-18	\$2.50	Y	4	N	Opened by Public Works for winter sand screening in 2010. Clean sand, fine gravel, small cobbles. No taking or selling from pit piles.
20. Lambert Road	SE-NE 15-66-20	\$2.50	N	4	N	Multiple small sales to landowners on Black Duck Lake and for harvest road building in the area.
21. McCue	GL4 33-62-21	\$2.50	N	4	N	Sandy with silty layers. Coarser near entrance. Soft floor. Old pipe gate, no lock.
22. Moose Lake - 180	NW-SW 21-65-19	\$2.50	Y	4	N	Sandy with limited rock and clay binder, but crushable.
23. Nett Lake	NW-NE 34-65-21	\$2.50	N	4	N	Clean pit run, mixed material suitable for crushing. Observe North property line.
24. Novak	SW-SW 12-65-19	\$2.50	N	4	N	On Clear Lake Grade. Logger use. Past PW crushing, but fairly remote.
25. Range Line	GL6 6-61-18	\$2.50	N	4	N	Clean sand and fine gravel with few cobbles. Sprawling pit, sporadic use. Parts of pit closed, sloped, seeded, and mulched in 2015.
26. South Winchester	SW-SE 18-64-17	\$2.50	N	4	N	Remote, in Winchester Lake Road system.
27. Swan Lake	NW-SE 11-65-20	\$2.50	N	4	N	Good pit run and crush site, but remote from Hwy 53 for most private sales.
28. Townline	SE-SE 34-66-20	\$2.50	N	4	N	Clean sand, gravel with small cobbles. Good for septic sand and pit run, insufficient rock for crushing. Located 0.25-mile North of Townline Road on East side of Lost River Road.
29. Vermilion Dam	GL3 2-63-17	\$2.50	Y	4	Y	Clean gravel and sand with rock. Low on binder in the past. Extensive reserves.

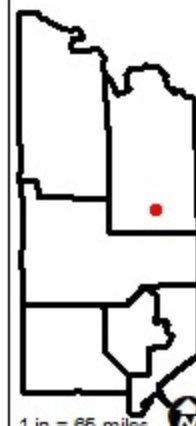
