OFFICIAL PROCEEDINGS OF THE MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF ST. LOUIS, MINNESOTA, HELD ON FEBRUARY 21, 2023

The Board of County Commissioners of the County of St. Louis, Minnesota, met this 21st day of February 2023, at 9:32 a.m., at the St. Louis County Courthouse, Duluth, Minnesota, with the following members present: Commissioners Annie Harala, Ashley Grimm, Keith Musolf, Mike Jugovich and Chair Patrick Boyle - 5. Absent: Commissioners Paul McDonald and Keith Nelson - 2.

Chair Boyle asked for a moment of silence in remembrance of all victims of violence, foreign and domestic; followed by the pledge of allegiance.

Chair Boyle opened the meeting to persons who wish to address the Board concerning issues not on the agenda. Melissa Bell, of Duluth, said the Conditional Use Permit (CUP) issued to 6464 Fredenberg Lake Road should be null and void. Ms. Bell commented that gravel pits have been treated differently. The Dirt Factory and Clearwater pits were cited for reclamation issues; however, both gravel pits operated by Lakehead Trucking Inc. have not been written-up for reclamation issues. Clayton Cich, of Fredenberg Township, commented that the county is violating civil rights by treating certain people differently under the same laws. Mr. Cich commented that the McKeever gravel pit should be closed and reclaimed. Bruce Anderson, of Duluth, said citizens have presented the Board with enough documents to fix the situation regarding the 6464 Fredenberg Lake Road gravel pit. Allen Richardson, of Duluth, spoke in opposition of the Huber Engineered Woods proposed plant and proposed that the county consider a hemp-based product. Tracey Dagen, of Boise Forte, said she opposes the Huber mill because of the impacts to clean water.

Commissioner Harala, supported by Commissioner Jugovich, moved to approve the consent agenda. The motion passed; five yeas, zero nays, two absent (McDonald, Nelson).

Commissioner Musolf, supported by Commissioner Harala, moved to remove from the table a bid award to Century Fence Company, Pewaukee, WI, for a 6" Wet Reflective Edgeline Project on various county highways and city streets within the City of Duluth (CP 0000-458863, SP 069-070-051, SP 118-070-004, HSIP 6923(155)). County Administrator Kevin Gray commented that the required agreements between the City of Duluth and the Minnesota Department of Transportation (MnDOT) were received and the project is ready to move forward. The motion passed; five yeas, zero nays, two absent (McDonald, Nelson).

Commissioner Musolf, supported by Commissioner Harala, moved approve the award of bid to Century Fence Company, Pewaukee, MN, in the amount of \$561,929.90 for project CP 0000-458863, SP 069-070-051, SP 118-070-004, HSIP 6923(155), 6" Wet Reflective Edgeline, located on various county highways within St. Louis County and various city streets within the City of Duluth.
